FEPA S.p.A. is first and foremost committed to ensuring compliance with applicable standards (both mandatory and voluntary) and to guaranteeing the continuous improvement of its environmental performance, which is a prerequisite for "sustainable development". To this end, specific environmental programmes are established and kept active, both to reduce environmental impacts and to optimise the use of resources, relating to the aspects considered most significant such as, for example, the management of water, energy, waste, raw materials.

The programme aims to achieve innovative results with environmental protection as a top priority. FEPA S.p.A. pursues this goal by developing products and production processes that minimise the impact on the environment and contribute to its preservation on a global scale.

In particular, the commitments undertaken by FEPA S.p.A. from an environmental perspective concern the following aspects:

1. Adopt a context analysis approach to identify relevant internal and external stakeholders and factors.

2. To make a useful contribution to society through the development of technologies and products oriented towards the conservation of resources and the environment.

3. To adopt production methods oriented towards the reduction of environmental impacts with particular attention to the reduction of consumption of energy resources, raw materials, hazardous substances, reduction of industrial waste production.

4. Identify, monitor and control significant environmental aspects and manage identified risks and opportunities;

5. Implementing all possible forms of environmental risk reduction through monitoring and control systems, adequate organisation of response to events, thorough training of personnel.

6. The use at a strategic level, where possible, of a product and process life cycle perspective;

7. Working in synergy with local authorities and national and international partners to define common environmental strategies.

8. Promoting awareness of environmental conservation among FEPA S.p.A. employees through training, awareness and involvement activities.
